Johannes Reinhardt owns property at the north corner of Route 14 and Larzalere Rd.
He has applied for a special use permit to operate a small farm winery- tasting room at this location once he has constructed the buildings. This is an Ag District.

Yates County Planning Board letter dated 3/26/12 approving the application with the condition that the applicant addresses the concerns of the Yates County Soil & Water letter to the YCPB Director dated 3/13/12. (Shawna Bonshak – Director)

Yates County Soil & Water dated 4/2/12 which states they have reviewed a set of updated plans dated 3/28/12 as prepared by Stephen Maybee P.E. for Kemmeter. The updated plans have addressed our concerns regarding erosion and sediment control practices for this project. (James M. Balyszak- District Manager)

Chairman asked Mr. Reinhardt to present his case. Johannes and his family have a long history of wine making in Germany. He presently is the wine maker for Anthony Road Winery. He came to the US as he wanted to go in a different direction in wine making and the Martini's have become his second family for the past nine years. He purchased the land a few years ago with the intention to have a small winery. Last year he installed drain tile. He will build his house and small barn first on the property. His financial institute suggested that in the future he may need to sub divide the property splitting the residence from the winery. He will build this site in phases, as his finances allow. He will locate the driveway off of Larzalere Rd this in keeping his plan of small operation. He plans on a 2000 cases per year production.. He has 13 acres in which he will plant vineyards. Business will be open April thru December. He has no plans for signage at this time. He has named his winery" Kemmeter", in homage of his heritage.

John Christensen Anthony Beach Rd. spoke in favor of the winery as evidence of the work so far on this land, he feel this will be an asset to the Town.

Kate Smith 1130 Rte. 14 asked about borders or fences, concerned about people wandering onto her woods property bordering Johannes property as she has small children.

Johannes stated that he will install deer fencing around his property to protect his grapes with a gate at the entrance.

Pat stated that he has read about Johannes and his family's long winemaking tradition as wine makers in a book " Summer in a Glass" by Evan Dawson. His expertise is an welcomed addition to the Town.

No one spoke in opposition to this application.

Being no further questions or statements on this application, Chairman thanked all for attending and their comments, closing the public hearing at 7:30 pm.
