

Town Board Minutes  
November 10, 2015

The monthly meeting of the Torrey Town Board was held on November 10, 2015 at 56 Geneva St and called to order by Supervisor Flynn at 7:30PM.

Present: Patrick Flynn, Burge Morris, Linda Francisco, John Martini, Colby Petersen

Others present: George Thompson, John Ghidiu, Dwight James- Code Officer, Tim Chambers- Hwy. Supt., Larry Martin, and Members of Boy Scout Troop # 82, Robert Clark, District II Legislator.

Mr. Flynn led the pledge of allegiance.

Mr. Flynn opened the public hearings on Local Law 2-15 and Local Law 3/15 at 7:35 pm

Local Law 2-15 to "Repeal 2014 LL 4-14 over riding the Tax Levy Limit for Budget 2015" as the Town did not exceed the Tax Cap Limit for 2015.

Local Law 3-15 entitled " Over ride the Tax Levy Limit established in the General Municipal Law§3-c for 2016 Budget".

No one desiring to speak on either Law,

Mr. Flynn went on to general business and presented the abstracts of vouchers for audit.

Motion by Mr. Morris, 2<sup>nd</sup> Mrs. Francisco, that the bills on the General A & B accounts in the amount of \$ 23,847.93 be paid, carried

Motion by Ms. Martini, 2<sup>nd</sup> Mr. Petersen, that the bills on the Hwy DA & DB accounts in the amount of \$ 14,766.82 be paid carried.

Motion by Mr. Morris 2<sup>nd</sup> Mrs. Francisco that the final Installment on fire contract in the amount of \$ 30,900. be paid carried.

Mr. Flynn gave a report on the Justice Audit for Judge Mashewske's September 1, 2014- August 31, 2015 financial reports. The audit states all records are found in good order.

Mr. Flynn offered the following resolution, 2<sup>nd</sup> by Mr. Morris,

**WHEREAS**, the Town of Torrey Town Board on October 13, 2015 did request

that the Torrey Justice Financial Records for the Year September 1, 2014 – August 31, 2015 be audited and

**WHEREAS**, an audit was performed on November 3, 2015 on the Town of Torrey Justice Financial Records for the year Sept 1, 2014 – August 31, 2015, this audit took place in the Town Offices at 56 Geneva Street, Dresden, NY, and

**THEREFOR BE IT RESOLVED**, on November 10, 2015 the Town of Torrey Town Board did receive and approve the audit report on the Town of Torrey Justice Financial Records.

Presented by Councilmen Petersen & Supervisor Flynn, who's findings were that to the best of their knowledge, the Torrey Justice Financial Records for the financial year stated above to be true and correct.

Mr. Morris made a motion 2<sup>nd</sup> by Mr. Petersen authorizing the Supervisor to sign the 2016 Fire Protection Contract with the Village of Dresden for \$ 95,000 carried.

Motion by Mr. Morris 2<sup>nd</sup> Mr. Flynn to approve the October regular meeting minutes, and 2016 Budget hearing minutes, carried by all.

Mr. Chambers reported repair on the grader and mechanical issues with Torrey 2. Highway is hauling stone for next year's road work. Took delivery of new slide in sander.

Mr. James gave the Code report. Traveled 192 miles for inspections and site visits.

Jeremy DeLyser of Clark Patterson & Lee Engineering presented the board with Map Plan Report for Water District 1 Northern town line on Rte 14. He stated that MPR for Perry Point Rd Water District will be completed in a few weeks. Now the Attorney for the Town will draw a petition to be past to landowners effected by residents.

Discussion on water funding available and how it is distributed. Outside funding may effect amount received from USDA.

There being no one desiring to speak in behalf or opposition of Local Law 2-15 and Local Law 3-15 Mr. Flynn closed the public hearing at 8:05pm,
