Mr. Hullings follow his business plan as submitted.

Mr. Hullings along with his father Ralph would like to operate a wood and fiberglass restoration business in an existing building in the Community Center District. They like how the property is layed out it allows for the business growth .Presently he is in the process of a lease contract with owner Ross Castner. A letter from Mr. Castner with the leasing intentions was presented as proof. Mr. Hullings submitted a business plan with all aspects of the restoration and storage. The building is 6350 Sq feet. They will be partitioning off 3000' for the restoration workshop area with office. The remaining 3250' will be used for boat & trailer storage along with cars and campers. They have inquired around and there is a need for this business, the closest is in Branchport.

Discussion on wood chips from the planer. They will have a wagon for these, Mr. Hullings has been contacted by landscaper for these chips to be used in flower beds.

No one spoke in support or opposition of this application.

Asked what chemical and waste plan. Mr. Hullings stated that all waste would be placed in proper containers and disposed of by waste management companies.
